Kamux's <u>share-based incentive plan for 2024–2026</u> was published on March 1, 2024.

Kamux's updated strategy for 2024-2026

The strategy is anchored to placing the customer at the core of all activities and improving operational efficiency as well as profitable growth, which is facilitated by these two measures. We can accelerate organic growth with acquisitions as well as by building strategic partnerships.

Our vision is to be the number one used car retailer in Europe. This is achieved by strengthening Kamux's concept and processes, as well as by developing the showroom network and selection.



Outlook for the year

Kamux expects its adjusted operating profit for 2024 to exceed its 2023 adjusted operating profit, which was EUR 18.0 million.
